 - 1.1. the delisting from the Interest Rate Market of the JSE of, on a Note-by-Note basis, all the 2010 Notes and all the 2017 Notes; and, should the Issuer so desire, the deregistration from the Interest Rate Market of the JSE of the 2010 DMTN Programme and the 2017 DMTN Programme;
 - 1.2. in the case of the 2017 Notes only, the waiver by the 2017 Noteholders of their rights to enforce in accordance with Condition 10.8 (Redemption in the event of a failure to maintain a JSE Listing and Rating):
 - 1.3. once the relevant notes have been delisted and the relevant waivers in paragraph 1.2 (if applicable) have been granted, the amendment of the relevant notes to delete all requirements that require JSE approval/consent or require notification be given to the JSE in relation to any of the terms and conditions of the relevant notes; and
 - 1.4. the amendment and restatement of the relevant notes.
- 2. Noteholders were given until 31 August 2021 to vote on the relevant extraordinary resolution.
